Summary Talking Points

1. Sabrient leverages a **process-driven methodology** developed by former engineers and forensic accountants to build quantitative, fundamentals-based, multifactor models and a “*quantamental*” (quantitative screen plus fundamental review & selection) approach (Slides 4-5).
2. The **Baker’s Dozen Annual Model Portfolio** launched January 2009 (near bottom of Global Financial Crisis). Over the full 17 years, it shows an **average annual gross total return of +20.3%** vs. +14.7% for SPY, and over the past 3 years it has averaged **+34.4%** vs. +22.9% for SPY (Slide 6).
3. Our suite of portfolios includes quarterly **Baker’s Dozen, Dividend, and Small Cap Growth**, and annual **Forward Looking Value**. Of our most recent portfolios, **30 of 35 (86%)** have outperformed or stayed close to their benchmarks (gross total return) (Slide 8).
4. The latest **Q1 2026 Baker’s Dozen** launched on 1/20 with 13 concentrated positions across a diverse group of Large/Mid/Small caps (3/7/3) and a 10/3 split between Growth/Value (Slide 7). The *Baker’s Dozen* is designed to offer the potential for outsized gains — for example, Q1 2024 portfolio had gross total return **+45.7%** vs. SPY +8.2%, Q3 2024 portfolio finished **+41.7%** vs. SPY +24.1%, and Q1 2025 Baker’s Dozen is **+36.1%** vs. +16.1% for SPY.
5. The latest **Small Cap Growth 49** launched on 12/19/25. It provides an alpha-seeking alternative to a passive position in the Russell 2000 Index for small-cap exposure in anticipation of improving market breadth.
6. The **new Dividend 55 launched on 2/5** and offers a **3.64% current yield** (as of 2/27). It employs a GARP & Income strategy with bond-like income while seeking capital appreciation from quality companies with solid earnings growth. Our Dividend portfolios are having a notably strong start to the year.
7. The annual **Forward Looking Value 13** launched on 8/15/25 with a small/mid-cap bias. It is a less-concentrated and more value-oriented version of Baker’s Dozen and offers an alpha-seeking alternative to a passive position in S&P 500 Value Index. It is in secondary market and closed to new investors.
8. One key alpha factor is our Earnings Quality Rank (EQR), an accounting-based risk assessment signal used in all our portfolio strategies. It is also licensed as a quality prescreen to the **First Trust Long-Short ETF (FTLS)**, an actively managed, low-beta portfolio that is approaching \$2.2 billion in AUM.
9. Our **Sector Rotation Model Portfolio** has a neutral bias and suggests holding Technology, Telecom, and Basic Materials (Slide 10).
10. Uncertainties persist with trade deals and tariffs, wars (now including Iran), federal debt, civil strife, midterm elections, Fed policy, and high valuations. But **fundamental tailwinds outweigh headwinds**, in our view, given continued AI optimism, robust capex, rising global liquidity, lower tax and interest rates, disinflationary trends, deregulation, re-privatization, re-industrialization, and rising productivity/margins/earnings (Slides 11-12).
11. Rather than the pricey passive cap-weighted indexes dominated by Big Tech, **investors may be better served by active stock selection** that seeks under-the-radar and undervalued gems primed for explosive growth. *This is what Sabrient aims to do in our various portfolios*, all of which provide exposure to Value, Quality, Growth, and Size factors and to both secular and cyclical growth trends.

What We Do: Our Active “Quantamental” Approach

1. **Quantitative screen** to narrow large eligible universe (50-100 names)

Forward P/E, forward EPS growth, recent dynamics of analyst consensus estimates, earnings quality (based on expertise of subsidiary Gradient Analytics), consistency & reliability of earnings growth

2. **Fundamental analysis** to identify top candidates (approx. 25 names)

Still mostly numbers-driven but not algorithmic. We also review recent news reports, long & short theses from Wall Street, and Canary Data for fundamental risk assessment.

3. **Final Stock Selection** (13 names)

Manual process, adhering to sector concentration limits

We believe a GARP strategy is “all-weather.” So, what could go wrong? Two things:

- 1) Consensus EPS estimates are reduced after portfolio launch or the company fails to achieve them.
- 2) Investor sentiment turns defensive, leading to narrow market breadth and avoidance of lesser-known firms.



The tables show gross total returns (without transactional sales charge, as displayed on the ftportfolios.com website) vs. a relevant benchmark for all the live portfolios plus some that recently terminated.

S&P 500 Value (SPYV) is the benchmark for Forward Looking Value, S&P 500 High Dividend (SPYD) is the benchmark for Dividend portfolios, and S&P 600 Small Cap Growth (SLYG) is the benchmark for Small Cap Growth.

The vast majority (71%) of portfolios created since enhancements were implemented in December 2019 have either outperformed or stayed close to their benchmarks. Moreover, **30 of the 35 most recent portfolios (86%)** shown on this slide across the four themes are outperforming or staying close to their benchmarks.

To illustrate the **outperformance potential**, Q1 2024 Baker's Dozen finished **+45.7%** vs. +8.2% for SPY, Q3 2024 Baker's Dozen finished **+41.7%** vs. +24.1% for SPY, soon-to-terminate Q1 2025 Baker's Dozen is up **+36.1%** vs. +16.1% for SPY, and SCG 46 is up **+54.9%** vs. +31.1% for SLYG.

Sabrient's **Outlook Score** employs a forward-looking fundamentals-based scoring algorithm to create a composite profile of the constituent stocks. **Bull Score** and **Bear Score** are based on price behavior of the underlying stocks on particularly strong and weak days over the prior 40 market days. High Bull indicates a tendency for relative strength in a strong market, and high Bear indicates a tendency for relative strength in a weak market (i.e., safe havens). High for all scores is 100, and higher is better.

Our SectorCast rankings reflect a slightly **neutral bias**, as cyclicals, secular growth sectors, and defensives are mixed throughout the rankings. Technology remains firmly at the top despite a relatively high valuation as investors are willing to pay up for strong growth and high margins.

Defensive sentiment remains elevated from the many macro uncertainties and growing concerns of an AI bubble and Fed rate-cut reluctance. Moreover, jobs growth has been stagnant and consumer sentiment is dicey, while global conflicts have escalated (e.g., Iran)—as has domestic politics in advance of the midterm elections. But optimism persists about fiscal stimulus (tax cuts and deregulation), rising productivity, strong GDP and earnings growth forecasts, stable inflation, falling interest rates (with the 10-year Treasury below 4% and 30-year mortgage below 6%).

Technology still displays the highest forward P/E (24.4x), although down a lot from above 30x. But it remains atop the rankings due to strong and rising EPS growth estimates (23.2%), the **lowest** forward PEG ratio (1.05), solidly positive sell-side analyst earnings revisions, by far the highest profit margins and return ratios, and the strongest insider buying. Financials has the lowest forward P/E (13.9x). Notably, Basic Materials no longer enjoys the lowest forward PEG as its price has surged along with commodity prices.

Our **Sector Rotation Model Portfolio** reflects a **neutral bias** based on S&P 500 falling below its 50-day moving average but still above its 200-day. The model suggests holding **Technology (IYW)**, **Telecom (IYZ)**, and **Basic Materials (IYM)**—which is the same as the bullish positioning.

Market Observations & Outlook - 1/2


1. Stocks have been mostly flat so far in Q1 2026, with defensives, low-volatility, high-dividend, Industrials, and value leading—and Big Tech trailing. The Dow Industrials and S&P 500 briefly eclipsed 50,000 and 7,000 but then pulled back, while the equal-weight S&P 500 continues to hit new highs. As of 2/27/2026, the forward P/E on cap-weighted S&P 500 (SPY) is 22.0x but equal-weight S&P 500 (RSP) is 18.0x, while S&P 600 small-cap (SPSM) is just 15.3x. **Multiples have been converging** as the market broadens.
2. **Uncertainty persists** with heightened volatility given trade deals/tariffs, Ukraine/Russia, Iran, Venezuela, Cuba, federal debt, civil strife, political polarization, midterm elections, Fed policy, high valuations, a weak jobs market, and signs of consumer distress. However, credit spreads remain tight. Forecasts for growth and corporate margins & earnings are strong as the private sector retakes its rightful place as the primary engine of growth, with much more efficient capital allocation and ROI than government decisions. **Disinflationary trends have resumed**, including implementation of AI and automation, rising productivity, falling shelter and energy costs, peace deals and neutralizing sponsors of terror, a firmer dollar, and the deflationary impulse on the world from a struggling China.
3. We believe **fundamental tailwinds outweigh headwinds**, and indeed investors seem to be positioning for continued AI progress, robust capex for AI and re-industrialization, looser Fed monetary policy, rising global liquidity, full enactment of the One Big Beautiful Bill Act (OBBBA), including tax and interest rate cuts, deregulation, smaller government, and re-privatization. This should continue to attract foreign capital into the US, cut the debt and deficit-to-GDP ratio, and unleash organic private sector growth, with stock valuations driven by rising earnings rather than multiple expansion.

Market Observations & Outlook - 2/2

4. The Fed remains behind the curve. A fed funds rate near 3.0% seems right, and fed funds futures suggest 82% odds we get there by the end of 2026—particularly with the newly Fed chair nominee Kevin Warsh. Bond yields have normalized with **10-year Treasury falling below 4.0% and the 30-year mortgage finally below 6.0%**—and likely will continue to fall with inflation, particularly given yield curve control (YCC) as the Treasury issues new debt on the short-end while Fannie Mae and Freddie Mac buy mortgages on the long end, driving down rates. Indeed, the economy needs lower interest rates along with business-friendly fiscal policy to: a) sustain rising global liquidity, b) relieve indebted consumers and businesses, c) support US and global economies, and d) avert a global credit crisis.
5. At the core of an equity portfolio still should be US Big Tech stocks, given their entrepreneurial culture, disruptive innovation, wide moats, global scalability, huge cash stores, resilient and durable earnings growth, and world-leading margins, ROI, and free cash flow. But a **broadening market, falling interest rates, and rising liquidity** suggest opportunities in small/mid caps, value, quality, cyclicals, equal-weight indexes, and sectors like industrials, financials, materials, and healthcare, plus dividend stocks, commodities, and bitcoin.
6. Thus, rather than the passive cap-weighted indexes, investors may be **better served by active stock selection** that seeks to identify under-the-radar, undervalued, high-quality gems primed for explosive growth. **This is what Sabrient seeks to do in our various portfolios**, all of which provide exposure to Value, Quality, Growth, and Size factors and to both secular and cyclical growth trends.
